2. COMPOSITION / INFORMATION ON INGREDIENTS

Inert Natural Rubber Latex (NRL), and/or fillers, and/or colorants/dyes

Ingredients are permanently bonded during the manufacturing process and do not pose a hazard when handled properly.

3. HAZARDS IDENTIFICATION

Warning: Isolated cases of allergic reactions to latex rubber or powder have been reported. If a reaction to this product is experienced, discontinue use immediately and seek medical help. This product contains Natural Rubber Latex which may cause allergic reactions in some individuals. Other components used in making gloves may also cause allergic reactions in some users.

4. FIRST AID MEASURES

Remove from contact immediately and wash affected area with saline water. If there is no relief seek medical attention. If a reaction to this product is experienced its use should be discontinued immediately and medical attention sought. If a reaction is experienced do not continue wearing a latex product until a latex protein allergic reaction has been ruled out.

5. FIRE AND EXPLOSION DATA

Stable. Material will not support combustion. Hazardous polymerizations will not occur.

Extinguishing Media – Use dry chemical CO₂, or Foam, or Water.

Special Firefighting Procedures - Main thermal decomposition products are Isoprene and Dipentene.

Use self-contained breathing apparatus.

Recommended Storage Conditions - 32° - 95° F

Store cool and dry, absence of direct or artificial light. Store away from ozone and ozone-generating sources. Recommend NOT storing on topmost pallet rack position to avoid close exposure to overhead lighting.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

See warning in section 3.

No respiratory, eye or skin protection is necessary unless the potential for allergic reactions exist.

Appearance - Shoe covers are clean and free from obvious defects, thin spots, holes and contamination. Material thickness is consistent throughout the product to minimize premature failure and maintain overall functionality.

Color - Colors are consistent within and between lots.

Physical Form - Solid

Density - $1.20 \pm .04$ g/ml

10. STABILITY AND REACTIVITY DATA

Product is stable and non-reactive in typical ambient conditions. Avoid excessive heat, moisture and strong oxidizers

11. TRANSPORTATION INFORMATION

This product is non-hazardous according to the United States Department of Transportation Code of Federal Regulations (CFR), Title 49.

12. DISPOSAL CONSIDERATIONS
