Directions • do not dilute solution or reuse bottle

- hold container a few inches above the eye or skin
- control flow of solution by pressure on bottle
- flush affected area as needed • continue flushing with water if necessary

- not for use as a contact lens solution • twist cap to open
- use before expiration date marked on bottle.
- store at room temperature, 15° to 30° C (59° to 86° F).
