DIRECTIONS FOR USE Typical use concentration is 0.5 - 1.0%, depending upon conditions. Make sure that all detergents are completely flushed out of the system before adding Ultrasil MP. Circulate for at least 10 - 15 minutes and allow to soak as required. After using this product membrane surfaces must be thoroughly rinsed with potable water.

For long-term storage, recommended concentration is 1.5%. Maintain Ultrasil MP solution in the membrane element housings to assure proper return of functionality.

NOTE: Observe the recommendations of the membrane manufacturers for maximum temperature, pH, and time limits.

Consult your Ecolab Representative for specific use instructions and recommended dispensing equipment.
