PRODUCT DESCRIPTION


Design: Coverall with double zip entry, no drip double comfort cuffs and boot overflaps; elasticated wrists, ankles and waist, hoods are elasticated in applicable models.

Garment material: 101 gsm multi layer barrier laminate (2.98 oz/yd²)

Garment seams: Welded and taped
